- II.** Applications involving proposed new buildings, or significant alterations, should include a floor plan indicating the ground floor area, number of stories, dimensions and, where applicable, number of residential units contained within.
- III.** If applying for a variance for similar use or approval of a discretionary or secondary use, attach a letter outlining the proposed business or use, part of the property required, customer volume and parking arrangements.
- IV.** Signature of Land Owner (if not applicant), and payment of the \$100 application processing fee for All Variances, (dimensional, temporary, similar use, development officer).
- V.** If applying for a sub-division, indicate on the plan the total area to be sub-divided including the number of lots, streets, public dedication, etc. In addition, indicate whether there are existing buildings on the land and if so, are they to be retained, demolished or changed externally.
- VI.** Subdivision Type 1-- \$200 + \$25/ lot; Subdivision Type 2 (public roads & private access) --\$500+ \$50/lot
